- (2) (Supplied) M/s a corporation incorporated
under the laws of and having its principal place of business at address of the

NOW THIS AGREEMENT WITNESS AS FOLLOWS:

1. In this agreement words and expression shall have the same meaning as are
respectively assigned rate to them in the Condition of contract referred to.

2. The following document shall constitute the Contract between the purchaser and the
supplier, and each shall be read and construed as an integral part of the Contract, viz:

- (a) This Contract Agreement
 - (b) Terms and Conditions (special term/General term of contract);
 - (c) The supplier's Bid, original Price Schedule and schedule of supply;
 - (d) The purchaser's Notification of Award of Contract;
 - (e) The form of Performance security/ stated in acceptance letter. (Nu.)
3. This contract shall prevail over all other contract documents. In the event of any discrepancy or inconsistency within the contract documents, then the documents shall prevail in the order listed above.
 4. In the consideration of the payments to be made by the purchaser to the supplier a hereafter mentioned the supplier here by covenants with the Purchaser to provide goods and services and to remedy defects therein in conformity in all respects with the provision of the Contract.
 5. The purchaser hereby covenants to pay the supplier in consideration of the provision of the goods and related services and the remedying of the defects therein, the Contract Price or such other sum as may become payable under the provision of the contract at the times and in the manner prescribed by the Contract.
 6. The quality and quantity of goods and services shall be examined with the full authority with the involvement of BAFRA or that trade staff as required.
 7. The supplier shall maintain ready stock of the items required for prompt services to fulfill the requirement of the purchaser even during short notice.
 8. The purchaser reserves the right to place order for any items within the preview of Items covered in the quoted rate.
 9. The supplier shall be responsible to employ caterer. (Purchaser will not entertain caterer)
 10. If the award of contract fails will be awarded to the second lowest and note the performance of failing supplier in the future participation in such contract work.

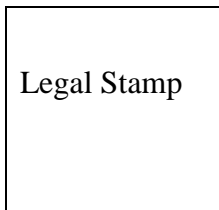
